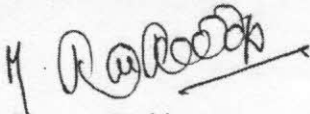

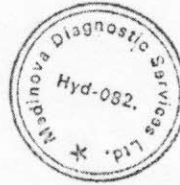

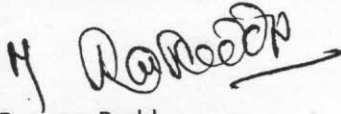

With reference to the above subject, pursuant to the resolution passed by the Board of Directors of the Company on **29.11.2016**, I was appointed as scrutinizer for conducting the postal ballot process, in connection with the item of business as provided in the Postal Ballot Notice, dated **29.11.2016**.

In terms of Companies (Management and Administration) Rules, 2014, I submit my report as under:

1. The Company completed the dispatch of notice along with postal ballot form and postage pre-paid business reply envelope to its members, whose names appeared in the Register of Members / List of Beneficial Owners as on 02.12.2016 through post/e-mail on 12.12.2016.
2. The Company engaged the services of National Securities Depository Limited (NSDL) (hereinafter referred to as the "**Service Provider**") for providing the e - voting platform to the shareholders of the Company. The service provider provided a system for recording the votes of the shareholders of the Company electronically on the items of the business as laid in the Postal Ballot Notice, dated **29.11.2016**
3. The cut-off date for the purpose of identifying the shareholders entitled to exercise their vote on the resolutions was fixed as 02.12.2016.
4. The e-voting facility was kept open by the Company during the period commencing on 13.12.2016 (09.00 hours) and ending on 12.01.2017 (17.00 Hours).
